

TERMS OF AGREEMENT

The 2020 Aggieland Invitational will be held in Bryan College Station on **December 28-30, 2020**. This document specifies the terms and conditions of all benefits provided to the participating teams while playing in the 2020 tournament.

HOUSING: Bryan College Station Sports + Events will provide each Team **three (3) complimentary hotel rooms per night on December 28 & 29**, and all additional rooms will be provided at a group rate. The Team will be responsible for any additional costs charged to the room including, but not limited to, local and long distance telephone charges, internet, in-room movie charges, meals charged to the room, etc.

PAYMENT: Participating Team agrees to pay a **\$300 registration fee** to participate in the 2020 Aggieland Invitational. Payment must be received by **December 11, 2020**. Please make checks out to *"Experience Bryan College Station."*

LATE FEE: Team will be charged an additional **\$50 late fee** if payment not received by December 11, 2020.

REFUNDS BEFORE 60 DAYS OUT: Full refund of fees or deposit requires advance written notice of cancellation to the BCS Sports and Events staff **60 days or more** prior to first event day (Dec. 28).

REFUNDS AFTER 60 DAYS OUT: If participant teams cancel **less than** 60 days in advance of the originally scheduled date (Dec. 28), any fees or deposits will be forfeited by the team in favor of BCS Sports and Events.

CONFIRMATION: Teams will be placed on a list for **"Intent to Participate"** after submitting Terms of Agreement. Please note that this does **NOT** guarantee a spot in the tournament. A selection committee will evaluate all teams with stated interest and select an exclusive list based off of a variety of factors. You will receive an email by **April 10, 2020** confirming or denying your Team's participation. This vetting process is due to the continuous growth of Aggieland Invitational.

You agree to attend the tournament in its entirety for the games in which the team is scheduled. If the division is full (32 teams), then the team is guaranteed four games. The team also agrees to pay all fees by the given deadline. If these conditions are not met, the committee has the right to prohibit participation in current, as well as any future tournaments.
